CCPAPP must request your contract participation directly with the vaccine manufacturer. Once you are linked to our agreement(s), orders for Merck, Sanofi Pasteur, and Pfizer products must be made directly with the manufacturer. Orders for **AstraZeneca** must be made through an authorized distributor. Orders placed through distributors or other companies for Merck, Sanofi Pasteur, and/or Pfizer products will not receive CCPAPP's contracted pricing.
